

Andy Petenbrink provided this copy of Joseph Shuckhart's Application for Reimbursement to Korns.org. In regards to question 3, Andy writes "George William Shuckhart's wives are listed as Elizabeth Nickel and Mary Pidenberink. Elizabeth is Anna Elizabeth's daughter, born prior to her marriage to Christian. Mary Pidenberink is Mary Petenbrink daughter of Christian and Anna Elizabeth Petenbrink. George Shuckhart's original application for a pension indicates that he married Elizabeth on 12 Mar 1859 and married Mary Peppenbrink on 11 May 1868."

On this 19 day of December, A. D. one thousand nine hundred and Twelve, personally appeared before me, a Justice of the Peace within and for the County and State aforesaid, Joseph M. Shuckhart aged 37 years, a resident of Frostburg, County of Alleghany, State of Maryland, who, being duly sworn according to law, makes the following declaration in order to obtain reimbursement from the accrued pension for expenses paid (or obligation incurred) by claimant for the last sickness and for the burial of George W. Shuckhart, who was a pensioner of the United States by certificate No. 938308, on account of the service of George W. Shuckhart in Co. C. 2nd Regt P.H.B. Md. Volk. Inf. (Name of soldier or sailor.)
 (Describe service by company and regiment, etc., if in the Army, or by the words U.S. Navy, if in the Navy.)

That pension was last paid to Sept 4th, 1912, by the U. S. Pension Agent at Washington D. C.

That the answers to questions propounded below are full, complete, and truthful to the best of my knowledge, information, and belief, and that no evidence necessary to a proper adjustment of all claims against the accrued pension is suppressed or withheld.
